I/We grant you/or your employees, agents or representatives permission to operate the property as necessary for purpose of testing and /or inspection.

All work to be completed in a professional workman like manner according to standard marine practices. Any alterations or deviation from specifications involving extra cost will be executed only upon written approval, and will become an extra charge over and above the estimate. Any additional work to be performed on a time/materials basis at the standard labor rate. All agreements are contingent upon accidents or delays beyond our control. As required by state/federal law, our workers are fully covered by workman's compensation policies.

I/We agree that Coleman Marine Diesel is not responsible for any loss or damage to boat (s) contents or other Property in case of fire, theft or any other cause beyond its control.

I/We agree that by signing this contract, Coleman Marine Diesel may use any credit cards accepted in lieu of a cash deposit and /or as a means of payment for any charges incurred.

It is understood by both parties that I/We may pay by cash or pre-authorized check, after completion of repairs.

The prevailing party in any legal action to collect sums due under this agreement or to otherwise enforce or interpret the terms of this agreement shall be entitled to all costs incurred in connection therewith, including reasonable attorney 's fees.

In event this account shall remain unpaid for 10 days from the billing date, said account shall be deemed delinquent, and the amount thereof shall bear interest from its billing date at the maximum rate permitted by California State law.

Coleman Marine Diesel holds the right to accept my credit card as payment (after TEN days of non-payment. All credit card transactions over \$1,000.00 will incur a 3% processing fee).
